REQUIREMENTS TO REGISTER A HONG KONG PRIVATE LIMITED COMPANY

- 1 Director. Director(s) may be individual(s) of any nationality.
- 1 Shareholder. Shareholder(s) may be corporation(s) or individual(s) of any nationality.
- An individual Shareholder can also act as Director.
- The Company Secretary has to be a Hong Kong resident or a Hong Kong Corporation.
- A Hong Kong Private Limited Company must have a Registered Address in Hong Kong.

HOW TO APPLY - SCHEDULE

Step 1

Send us copy of these documents:

- Certified true copies of passport (or HK ID) and recent residential addresses proofs of each director.
- Certified true copies of passport (or Hong Kong ID) and recent residential addresses proofs of each shareholder. If shareholder is a corporation, please provide all its Certificate of Incorporation, BRC, Registers, Certificate of Incumbency and address proof.
- Application form duly filled with 3 company names to check availability for registration.

Step 2

After availability's confirmation of the proposed name and full payment of Shelf Ready Made Private Limited Company on demand reception, we will write shares transfer documents & consent to be first Director and you will sign them in our office in Hong Kong or we will send them for signature and sending back by courier (courier will be invoiced).

Step 3

Following day getting signed transfer documents we will start company transfer process at Inland Revenue Department, pay Stamp Duty and register Director(s) resignation/appointment at Companies Registry.

Step 4

Next day, you can start using your company.

Step 5 Corporate bank account opening following your choice.

→ in Hong Kong by yourself (**bank appointment must be booked 2-3 weeks in advance**).

a. Free OCBC Wing Hang corporate bank account appointment booking and opening minutes writing (business plan, business proofs and residency proofs must be communicated 2 weeks in advance).

b. Handling corporate bank account appointment booking by yourself.

c. Using our option (HKD 2,310 - USD 300) for appointment with any other bank of your choice (HSBC, Hang Seng Bank). Kindly note that all Director(s)/Shareholder(s) owning 10% or more shares/Beneficial Owner(s) should come to Hong Kong for corporate bank account opening appointment;

→ by yourself in countries of your choice with an Apostille Kit of company documents;

→ using our assistance for remotely Neat business corporate bank account for SME opening with Standard Chartered Bank or Money Service Operator internet banking corporate banking solution opening (in both case you must satisfy Know Your Customer compliance and be approved by supplier).
